WHEREAS, the charge is in compliance with all laws pertaining to the levy of the particular assessment, Government Code, Section 53978; and

WHEREAS, the purpose of the assessment is to continue to provide fire protection and emergency response services;

THEREFORE BE IT RESOLVED, the rates for Fiscal Year 2023-2024 Woodbridge Fire District Measure U Special Assessment are set forth as follows.

8¢ per building square foot on improved parcels
\$45 per unimproved parcels
