Woodbridge Rural County Fire Protection District Resolution Adopting Special Tax Rates Set Forth by Ordinance 85-3208 Resolution 25-4

WHEREAS, the Board of Directors of the Woodbridge Rural County Fire Protection District of San Joaquin County adopts the following special tax rates for Fiscal Year 2025-2026 as set forth by Ordinance 85-3208; and

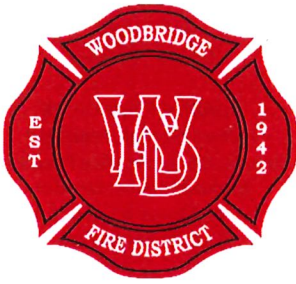
WHEREAS, the charge is in compliance with all laws pertaining to the levy of the particular assessment, Government Code, Section 53978; and

WHEREAS, the purpose of the assessment is to continue to provide fire protection and emergency response services;

THEREFORE, BE IT RESOLVED, the rates for Fiscal Year 2025-2026 Delta Special Assessment are set forth as follows.

Residential Dwelling:	7.5 cents per sq. ft.
Commercial Residential:	8.5 cents per sq. ft.
Agriculture:	5.5 cents per sq. ft.
Dairies:	5.5 cents per sq. ft.
Commercial:	8.5 cents per sq. ft.
Industry:	10.5 cents per sq. ft.
Marina or Yachting Clubs:	6.5 cents per sq. ft.
Berms:	\$2 per acre
Vacant Residential Lot:	\$30 per fiscal year
Vacant Commercial Lot:	\$20 per acre
Vacant Industrial Lot:	\$20 per acre
Gas Wells:	\$50 per fiscal year
Waste Lands:	\$10 per fiscal year
State Board of Equalization:	\$50 per acre
Mobile Home Residential Lot:	\$50 per fiscal year

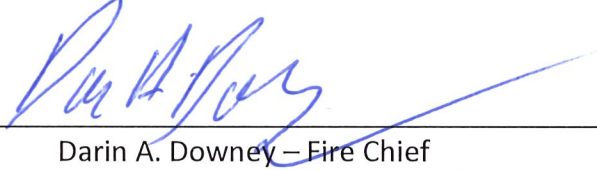
