FIRE CHIEF'S REPORT:

A. Alarm & Fire Prevention Report:

Chief Downey reviewed the Alarm and Fire Prevention Reports, and each board member received a copy. Alarm reports show 180 calls for the month of September 2023, bringing the yearly total to 1,694, an increase in 5 calls from the prior year. There were 17 fire inspections completed during the month of August.
