#### **BUSINESS NOT ON AGENDA FROM PUBLIC:**

- A. Al Wolter advised he submitted his application to San Joaquin County to remove the speed humps on East Augusta Street and is awaiting the forms for public signatures. The cost to remove the speed humps is estimated between 5K to 7K which will be the responsibility of the public to pay.
- B. Chief Downey advised the new rescue is back in production and the progress can be viewed on Pierce Manufacturing's website. The maintenance team will be flying out in the beginning of August for final inspections. Operations Chief Bernier has been elected to the FDAC Board of Directors.

#### A. Alarm & Fire Prevention Report:

Chief Downey reviewed the Alarm and Fire Prevention Reports, and each board member received a copy. Alarm reports show 209 calls for the month of May 2025, bringing the yearly total to 888, an increase of 69 calls from last year. The district completed 28 fire inspections during the month of May.
